WHEREAS, the Boards of the said Districts consider such unification beneficial in terms of planning and operation,

BE IT THEREFORE RESOLVED by the Boards of the aforesaid Districts that the respective Districts will enter into an agreement pertaining to establishing a Unified School District,

BE IT FURTHER RESOLVED that the said Boards respectfully requests, pursuant to 15-491-C, that the County School Superintendent of Navajo County, Holbrook, Arizona form a Unified School District between Whiteriver Elementary District No. 20 and Alchesay High District No. 20, beginning July 1, 1978.

BE IT FURTHER RESOLVED that the Unified District shall be known as, "Whiteriver Unified School District No. 20".

BE IT FURTHER RESOLVED that the clerk of the Board of Trustees of Whiteriver Elementary District No. 20, is hereby authorized to execute all necessary certificates certifying to the authenticity of this resolution, and,

BE IT FURTHER RESOLVED THAT the Clerk of the Board of Education of Alchesay High School District No. 20, is hereby authorized to execute all necessary certificates certifying to the authenticity of this resolution.
