

RESOLUTION NO. 132-84

BLUE RIDGE SEWER IMPROVEMENT DISTRICT ASSESSMENT AREA 83-A

A RESOLUTION CONFIRMING ASSESSMENT AND RATIFYING ALL PROCEEDINGS

WHEREAS, on May 1, 1984, the Board of Directors of the Blue Ridge Sewer Improvement District adopted a Resolution of Intention to order certain improvements within Assessment Area 83-A; and

WHEREAS, on June 24, 1984, the Board of Directors of the Blue Ridge Sewer Improvement District adopted a Resolution Approving the Diagram and Acknowledging the Recording of the Assessment for Assessment Area 83-A; and

WHEREAS, a Notice of Assessment has been published and mailed to the property owners of record within the area to be assessed in accordance with Arizona Revised Statutes Section 11-727E; and

WHEREAS, the Board of Directors of the Blue Ridge Sewer Improvement District held a hearing on July 24, 1984 to hear any objections to the assessments in Assessment Area 83-A; and

WHEREAS, at the hearing held on July 24, 1984 there was not a quorum of the Board of Directors of the Blue Ridge Sewer Improvement District; and

WHEREAS, on July 31, 1984 the Board of Directors of the Blue Ridge Sewer Improvement District adopted a Resolution authorizing that a second hearing on assessments be held on August 7, 1984; and

WHEREAS, a second Notice of Assessment has been published and mailed to the property owners of record within the area to be assessed in accordance with Arizona Revised Statutes; and


WHEREAS, the Board of Directors of the Blue Ridge Sewer Improvement District held a hearing on August 7, 1984 to hear any objections to the assessments in Assessment Area 83-A; and

WHEREAS, the Board of Directors of the Blue Ridge Sewer Improvement District has heard any and all objections by any owner, the contractor and all other persons interested in the work or in the assessment who have any objections to the legality of the assessment or to any of the previous proceedings connected therewith and hereby determines that any objections received were not sufficient to cause the modification of the assessments or effect the legality of any proceedings of the Blue Ridge Sewer Improvement District.


THEREFORE, BE IT RESOLVED:

1. The Board of Directors of the Blue Ridge Sewer Improvement District hereby confirms the diagram and assessment as heretofore recorded.
2. The Board of Directors of the Blue Ridge Sewer Improvement District hereby approves, ratifies, confirms and validates all proceedings in this matter heretofore taken.
3. Annual assessment installments are to be collected in the same manner as Navajo County taxes.
4. That in confirming said assessment the Board of Directors has reaffirmed its position set forth earlier in these proceedings in the Resolution forming said District and the Resolution of Intention to order the improvements that each parcel set forth in the assessment will be benefited by the improvements to be constructed.
5. The assessment so confirmed includes the sum due for the work performed and specified in the Contract and incidental expenses of said work and assessment.
