
Portions of section 4 and 5 of Township 8 North, Range 23 East, in the Pinetop area. (west of Pinelake road)


The Board of Supervisors does hereby adopt an extension for the period of 12 months for the amendment to the Navajo County Zoning Maps referred to herein, so as to change from the A - General zone to the Special Development zone.

The permit hereby allowed is conditional upon the privileges being utilized within one year after the effective date thereof, and if they are not in accordance with conditions imposed by the Board of Supervisors, this authorization shall become void, and any privilege, permit or variance granted shall be deemed to have elapsed.
