**RESOLUTION**

*81-85*

WHEREAS, WHITE MOUNTAIN WATER COMPANY, an Arizona corporation, has presented to the Board an Application for Franchise and the authority, together with all rights-of-way necessary, to extend, construct, maintain and operate its domestic water system for the purpose of furnishing water to residents and business establishments within the County of Navajo, State of Arizona, in an area more specifically described on Exhibit "A" attached hereto and made a part hereof by reference in Navajo County, Arizona, and having therewith presented the proposed Franchise to be granted, together with Notice of Intention to grant said Franchise for publication; and

WHEREAS, this Board is of the opinion that said domestic water system is necessary to provide water to residents and business establishments in the above-described area within the County of Navajo, Arizona, and that said Application should be granted;


NOW, THEREFORE, be it

RESOLVED, That said Franchise will be granted in accordance with the Application of White Mountain Water Company at 10:00 o'clock A.M., on the 24<sup>th</sup> day of September, 1985, unless before said date more than fifty percent (50%) of the qualified electors of Navajo County, Arizona, shall petition the Board of Supervisors to deny such privilege; and be it

RESOLVED FURTHER, That the Clerk of this Board cause

Franchise once a week for three (3) consecutive weeks prior to said hearing in the \_\_\_\_\_, a newspaper of general circulation, published within the County of Navajo, Arizona.

PARCEL NO. 1:

thence South 486 feet;

thence North 486 feet to the POINT OF BEGINNING.
