
PARTIAL ROAD ABANDONMENT

BE IT RESOLVED that this portion of the road easement recorded in Docket 272, Page 336 is hereby abandoned for public use and said easement is hereby extinguished, and


BE IT FURTHER RESOLVED that this action does not eliminate access to any adjacent parcel of land.


