
WHEREAS, the County of Navajo has entered into a Contract with the Arizona Department of Commerce to perform certain duties funded by Community Development Block Grant funds; and

WHEREAS, said Contract is known as Commerce CDBG Contract No. 476-85A; and


WHEREAS, the County has encountered certain unavoidable delays in completing the terms of the Contract;



Dear Supervisor Shumway:

Enclosed are four (4) copies of the CDBG Intergovernmental Agreement which have been signed by the Executive Director of the Arizona Department of Commerce. This new Agreement extends your initial FY 1984 CDBG Contract #476-85A through October 18, 1986 and allows the County to utilize the funds remaining from that initial contract. This new Agreement became necessary because Contract #476-85A terminated prior to the completion of an amendment process to extend that contract. Please sign and return all four (4) agreements as soon as possible, but no later than 30 days from the date of this letter. Upon receipt of the agreements, they will be recorded and one (1) completely signed copy will be returned for your file. Please note that Section 22. Special Conditions, which appears on page 6 of the IGA, explains the relationship of this Agreement to Contract #476-85A.

It is important that your legal counsel review the agreements prior to the authorized elected official signing the agreements. Your legal counsel must sign and note his/her review on the agreements or by a separate statement attached to the agreements pursuant to ARS 11-952.

The Intergovernmental Agreement does not become effective until filed with the Secretary of State.

At the time you receive your filed copy of the Intergovernmental Agreement, you will also receive forms for authorizing signatures, designating depositories, and requesting funds.
