The Board of Supervisors of Navajo County does resolve as follows:


The Board of Supervisors does hereby declare and determine that a zone change request was granted to Navajo County Planning Commission at a public hearing on the 21st day of December, 1987, to permit future control of development by site plan on the following property:

A PORTION OF THE NW $\frac{1}{4}$, SECTION 4, T8N-R23E, A.K.A. APN 211-57-01A, 010, 01C; PORTION OF THE S $\frac{1}{2}$, SECTION 3, T8N-R23E, A.K.A. APN 211-56-5A, 4A, 5B, 5C, 02, 03, AND ALL OF 211-80; PORTION OF THE NW $\frac{1}{4}$, SECTION 3, A.K.A. APN 211-40-15C, 15B, 15D, G&SRB, NAVAJO COUNTY, AZ. THE PINETOP COUNTRY CLUB AND PINETOP LAKES COUNTRY CLUB AREAS. THESE PROPERTIES ARE UNDEVELOPED AND FALL INSIDE AN AREA BOUNDED ON THE NORTH BY THE NATIONAL FOREST, THE EAST BY APACHE COUNTY, THE SOUTH BY THE APACHE INDIAN RESERVATION AND THE WEST BY HIGHWAY 260.

The Board of Supervisors does hereby ~~GRANT/DENY~~ an extension for the period of 60 months for the amendment to the Navajo County Zoning Maps referred to herein, so as to change from the A-General zone to the Special Development zone.

The Zone Change allowed is conditional upon privileges being utilized within five (5) years after the effective date thereof. Therefore, this authorization shall become void, and any privilege, permit or variance granted shall be deemed to have elapsed. The zoning classification on said property shall revert to A-General.

APN 211-56-01D. THE PINETOP LAKES COUNTRY CLUB AREA.


