
RESOLUTION OF SUPPORT

WHEREAS, the Town Council of the Town of Pinetop/Lakeside has functionally classified Woodland Road, from Highway 260 to Woodland Lake Road, as rural major collector; and

WHEREAS, the Town Council of the Town of Pinetop/Lakeside has requested through the Northern Arizona Council of Governments and the Arizona Department of Transportation, that this portion of road be designated as a Federal Aid Secondary Route; now




Dear Mayor Mullins:
