

RESOLUTION NO. 83-89

A RESOLUTION OF THE BOARD OF SUPERVISORS  
OF NAVAJO COUNTY  
REQUESTING THE ABANDONMENT OF AN EASEMENT

The Navajo County Board of Supervisors does hereby resolve as follows:

WHEREAS, the Board of Supervisors does hereby declare and determine that the following request for abandonment of this easement was initiated and filed by GENE RIEGEL, and a public hearing was duly held on the 20th day of July, 1989, to abandon part of easement located in section 29, T12N-R17E, G&SRM, Navajo County, Az; recorded in N.C. Book of Records, Docket 175, Page 247-8, and;

WHEREAS, the aforementioned petitioner has filed a request in accordance with the rules and regulations of the Navajo County Zoning Ordinance and Subdivision Regulations, and;

WHEREAS, the Board of Supervisors pursuant to ARS §18-210 and ARS §28-1902 has found that the subject roadway, street, alley or easement is/is not necessary for public use as a throughway, now;


THEREFORE, BE IT RESOLVED, that the Navajo County Board of Supervisors does hereby GRANT/DENY the abandonment of the easement on the described property to-wit:

Recorded in Navajo County Book of Records, Docket 175, Page 247-248, located between APN 206-15-021 and 205-15-009, that portion which runs northeasterly for 306 feet then northwesterly for 200 feet; located in Section 29, T12N-R17E, G&SRM, Navajo County, Arizona; the Overgaard Area.

**SUBJECT** to the attached **Stipulation**:

BE IT FURTHER RESOLVED that upon the abandonment of said easement the property described be vested in title and accrued to the owners of the land abutting such vacated portions pursuant ARS §28-1902.
