RESOLUTION NO. 60-90

A RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS AND PRIVATE INDUSTRY COUNCIL ADAPTING BY REFERENCE THE EXTENSION OF THE PROGRAM YEAR 1990/91 PIC/LEO AGREEMENT TO COVER (RETROACTIVELY) THIS CURRENT PROGRAM YEAR (JULY 01, 1990 - JUNE 30, 1991).

WHEREAS, Public Law 97-300, Job Training Partnership Act, (hereinafter referred to as the "Act"), authorizes the expenditure of federal funds for job training programs in locally established Service Delivery Areas; and

WHEREAS, Navajo County has been designated as a Service Delivery Area pursuant to Section 101 of the Act; and

WHEREAS, the Private Industry Council (PIC) has been established and certified pursuant to the requirements of Section 102 of the Act; and

WHEREAS, it is the responsibility of the PIC to provide policy guidance for, and exercise oversight with respect to activities under the Act in this Service Delivery Area in partnership with the Board; and

WHEREAS, the Board and the PIC are required to enter into operational agreements under Section 103 (B) (1) of the Act; and

WHEREAS, the operational agreement has not been finalized and signed for this current program year July 01, 1990 through June 30, 1991.

NOW, THEREFORE, BE IT RESOLVED that the PIC and the Board agree to extend the Program Year 1990/91 PIC/LEO agreement to cover (retroactively) the period beginning July 01, 1990 and end June 30, 1991.

BE IT FURTHER RESOLVED, that the terms and conditions of the Program Year 1990/91 PIC/LEO agreement shall be in effect during this current program year.

PASSED ADOPTED AND APPROVED by the Private Industry Council this Twenty First day of June, 1990, and by the Navajo County Board of Supervisors the 30th day of July, 1990 at Holbrook, County of Navajo, State of Arizona.
