RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS RE-ASSIGNING USDA EASEMENTS TO THE TOWN OF PINETOP/LAKESIDE

WHEREAS, the Town of Pinetop/Lakeside has incorporated certain areas of Navajo County; and


WHEREAS, within that area are roads that Navajo County has a USDA easement from the Forest Service; and

WHEREAS, the Town of Pinetop/Lakeside would like to take over the jurisdiction of those roads; now


THEREFORE, BE IT RESOLVED That Navajo County does transfer its interest in the following USDA easements to the Town of Pinetop/Lakeside.

- 1) Woodland Lake Road - Forest Service Road 316, as recorded in Docket 682, Pages 480-490 of Navajo County Records.
- 2) Rainbow Lake Road - Forest Service Road 12, as recorded in Docket 475, Pages 328-333 of Navajo County Records.
- 3) Porter Mountain Road - That portion of Forest Service Road 45, from State Highway 260, then Northerly to the Northeast corner of Porter Creek Estates, as recorded in Docket 483, Page 486, Part 1.
- 4) ShowLow Lake Road - Forest Service Road 82, as recorded in Docket 480, Pages 175-180 of Navajo County Records.
- 5) Wagon Wheel Road - Forest Service Road 9705L3, as recorded in Docket 429, Pages 842-848 of Navajo County Records.
