NORTHERN ARIZONA EMERGENCY MEDICAL SERVICES COUNCIL


WHEREAS, the Northern Arizona Emergency Medical Services (N.A.E.M.S.) Council has incorporated as the successor to the N.A.C.O.G. E.M.S. Advisory Council and wishes to continue to provide a regional voice in the planning and delivery of emergency medical services in this area; and,

WHEREAS, the Arizona Department of Health Services, Division of Emergency Medical Services has established a northern regional office in Flagstaff to plan and deliver such services and can serve as staff to the N.A.E.M.S. Council; and,

WHEREAS, the N.A.E.M.S. Council will provide eight seats for representatives of local governments in this region on the Council; and,

WHEREAS, a regional E.M.S. Council must obtain the approval of cities, towns, counties and fire districts containing at least 51% of the population of the region,

NOW, THEREFORE, BE IT RESOLVED THAT Navajo County Board of Supervisors believes that there needs to be a regional voice in the provision of emergency medical services in this region, that the newly incorporated N.A.E.M.S. Council can provide such a voice and that the northern office of the Arizona Department of Health Services, Division of Emergency Medical Services should provide adequate staff support for the Council as it carries out its oversight function.
