RESOLUTION NO. 78-93

RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS ADOPTING AN AMENDMENT TO INCORPORATE THE ARIZONANS WITH DISABILITIES ACT ACCESSIBILITY GUIDELINES (AzDAAG) INTO THE NAVAJO COUNTY BUILDING SAFETY CODE ORDINANCE

WHEREAS, the Navajo County Board of Supervisors has determined that the Navajo County Building Safety Code Ordinance needs to be maintained with current construction standards, and


WHEREAS, in June 1992, the Arizona Legislature adopted Title III of the Americans with Disabilities Act, and the physical accessibility standards of Title II of the Americans with Disabilities Act, into Arizona law as the Arizonans with Disabilities Act, ARS 41-1492.01 et seq., and,

WHEREAS, every State agency, department and political subdivision of the State which adopts and enforces a building code shall adopt and incorporate the Arizonans with Disabilities Act Accessibility Guidelines dated September 30, 1993, as an integral part of said State or local building code.


NOW, THEREFORE BE IT RESOLVED, that the Navajo County Board of Supervisors adopts this amendment by reference and incorporates the Arizonans with Disabilities Act Accessibility Guidelines by attachment to the Navajo County Building Safety Code Ordinance as passed by the Board on July 6, 1992.

AND BE IT FURTHER RESOLVED, that by the Navajo County Board of Supervisors, this amendment to the Navajo County Building Safety Code is herewith approved and adopted.
