RESOLUTION NO. 25-94

RESOLUTION OF NAVAJO COUNTY CERTIFICATIONS FOR THE STATE HOUSING TRUST FUND PROGRAM

WHEREAS, Navajo County is desirous of obtaining a grant from the Housing Trust Fund Program in order to serve as a match to a HOME Program Grant application; and

WHEREAS, in order to obtain this grant, certain certifications must be made;

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of the County of Navajo hereby certify that if approved by the Arizona Department of Commerce for a Housing Trust fund allocation, the County will meet the conditions required for use of the funds and certifies that:

1. it is eligible for award under state statute and program guidelines and agrees to comply with all applicable federal, state, and local regulation;
2. it will minimize displacement as a result of activities assisted with Trust Fund resources and assist persons displaced as a result of such activities;
3. it has resolved any audit findings or performance problems for prior local, state, or federal housing and community development programs;
4. before committing funds to a project, it will evaluate the project in accordance with guidelines that it adopts for this purpose and will not invest any more funds than are necessary to provide affordable housing;
5. the information, statements, and attachments contained in this application are, to the best of my knowledge and belief, true and correct;

6. it is prepared and has the authority within its statutory authority to enter into a contractual agreement with the Arizona Department of Commerce for acceptance and use of the Housing Trust Fund moneys, and makes this application and certification with full cognizance of its governing body.
