A RESOLUTION AND ORDER ADDING TERRITORY TO THE
PORTER CREEK DOMESTIC WATER IMPROVEMENT DISTRICT

WHEREAS, the Clerk of the Board of Supervisors of Navajo County set 17th, of July, 1995, at the hour of 10:00, a.m. in the Navajo County Board of Supervisors Chambers, Navajo County Governmental Complex, Holbrook, Arizona as the time and place for a hearing on an addition of Territory to the boundaries of the Porter Creek Domestic Water Improvement District and any objections thereto; and

WHEREAS, notice was appropriately posted, published, and mailed to the property owners pursuant to the provisions of A.R.S. Section 48-905; and

WHEREAS, it appears that the Petition is signed by the requisite number of owners of real property, and that the public convenience, necessity, or welfare will be promoted by the addition of Territory to the Porter Creek Domestic Water Improvement District.

NOW, THEREFORE, IT IS HEREBY RESOLVED, DETERMINED AND ORDERED AS FOLLOWS:


1. The Board of Supervisors finds that:

- a. The petition is signed by a majority of the persons owning real property, or by owners of fifty-one percent (51%) or more of the real property, which is the requisite number of owners as provided by A.R.S. Section 48-903;


- b. The public convenience, necessity or welfare will be promoted by the addition of Territory to the Porter Creek Domestic Water Improvement District;
 - c. Notice has been published, posted and mailed pursuant to A.R.S. Sections 48-905; and
 - d. The Territory to be annexed to and included within the Porter Creek Domestic Water Improvement District will be benefitted thereby.
2. That the boundaries of the Territory to be added to the Porter Creek Domestic Water Improvement District shall be those set forth in Exhibit "A" and Exhibit "B", attached hereto and incorporated herein by reference.
 3. That the District with the additional Territory shall continue to be known in all proceedings as the Porter Creek Domestic Water Improvement District.
 4. That these findings and orders are made after a public hearing as required by A.R.S. Section 48-905.
 5. That by virtue of the authority set forth in A.R.S. Section 48-906, the addition of Territory to the Porter Creek Domestic Water Improvement District is hereby ordered, and such Territory shall hereafter be considered to be included with the Porter Creek Domestic Water Improvement District, a body corporate with the powers of a municipal corporation for the purposes of carrying out the provisions of Title 48, Chapter 6, Articles 1, 2, 3 and 4 of the Arizona Revised Statutes.


