### RESOLUTION NO. 40-96

#### A RESOLUTION FIXING AMOUNT AND APPROVING BOND, FIXING TIME AND PLACE OF HEARING ON THE QUESTION OF FORMATION OF THE WILD HORSE ROAD NO. 1 IMPROVEMENT DISTRICT

WHEREAS, a Petition for the establishment of the Wild Horse Road No. 1 Improvement District in Navajo County, Arizona, pursuant to Article 1, Chapter 6, Title 48, Arizona Revised Statutes, which requests that if established, the District be named the Wild Horse Road No. 1 Improvement District, was received by this Board and filed with the Clerk hereof; and

WHEREAS, said Petition is certified by the Petitioners and is accompanied by a plat or sketch indicating the approximate area and boundaries of the proposed Wild Horse Road No. 1 Improvement District:

NOW, THEREFORE, it is resolved, determined and ordered as follows:

1. A Bond will be provided by reserving \$500 of District 5 Special Road Project funds.
2. That Monday, the 9<sup>th</sup> of September, 1996, at the hour of 10:10 a.m. said day being not later than forty (40) days from the date the Petition was filed, in the Supervisors Chambers, Navajo County, Holbrook, Arizona, is hereby fixed as the time and place when and where this Board will hear said Petition and all matters relating to the establishment of the proposed Wild Horse No. 1 Improvement District, and when and where all interested property owners may appear and be heard, and any person may appear and show cause, if any there may be, why the prayer of the Petitioners should not be granted, or why any territory should be excluded from said proposed Wild Horse Road No. 1 Improvement District, or other territory included therein, and all written objections to the establishment thereof shall have been filed with the Clerk of this Board before the date set for hearing.

3. The Clerk shall cause a signed notice, announcing the hearing and setting forth the boundaries of the proposed Wild Horse Road No. 1 Improvement District to be published twice, one week apart, in the White Mountain Independent, a newspaper of general circulation published in Navajo County, Arizona, the first of which shall be not less than ten (10) days prior to the date of the hearing, and to be posted pursuant to A.R.S. Section 48-905, not less than ten (10) days prior to the date of the hearing and to be mailed, by first-class mail to the home address of each property owner within the proposed Wild Horse Road No. 1 Improvement District.




# NOTICE OF HEARING ON ESTABLISHMENT OF PROPOSED IMPROVEMENT DISTRICT
