### RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS CANCELLING THE ELECTION FOR THE PORTER MOUNTAIN DOMESTIC WATER IMPROVEMENT DISTRICT PURSUANT TO A.R.S. §48-1012

**WHEREAS**, pursuant to A.R.S. §48-1012, the Navajo County Board of Supervisors may cancel the election for a County Water Improvement District office if an equal number of people file nominating petitions for election, as there are seats, on the Board of Directors of the District up for election; and,

**WHEREAS**, A.R.S. §48-1012 permits the Navajo County Board of Supervisors to appoint the people who filed the nomination petitions to fill the seats for election on the Board of Directors, if the election is cancelled;

**WHEREAS**, the Board of Directors of the Porter Mountain Domestic Water Improvement District has published the Call for Election for November 5, 1996, to fill (2) vacancies on the District Board; and

**WHEREAS**, (2) people have filed nominating petitions to fill (2) seats up for election and the date for filing nomination petitions has expired; and

**WHEREAS**, the Board of Directors of the Porter Mountain Domestic Water Improvement District have asked the Navajo County Board of Supervisors to cancel the election and appoint Loretta Moore and Willard Normark, who have filed nomination petitions for those positions; and


**WHEREAS**, no member of the District has voiced an objection to cancelling the election, nor has any member indicated a desire to seek election as a write-in candidate, to the Navajo County Board of Supervisors;

**NOW, THEREFORE BE IT RESOLVED**, that the Navajo County Board of Supervisors, upon request by the Porter Mountain Domestic Water Improvement District, does hereby cancel the election and appoint Loretta Moore and Willard Normark to the Board of Directors of the Porter Mountain Domestic Water Improvement District beginning January 1, 1997.
