A RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS

A RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS FOR APPROVAL OF THE FOLLOWING AMENDMENT TO THE NAVAJO COUNTY BUILDING SAFETY ORDINANCE PROVIDING FOR THE ADDITION OF THE AMERICANS WITH DISABILITIES ACT AND THE ARIZONANS WITH DISABILITIES ACT. ALSO INCLUDED WITHIN THE AMENDMENT ARE UPDATES TO THE TEXT WHICH REFLECT CURRENT TERMINOLOGY.

WHEREAS, the Navajo County Board of Supervisors has determined that the Navajo County Building Safety Ordinance needs to be maintained with current construction standards and terminology, and

WHEREAS, A.R.S. § 41-1492.03 requires that counties adopt as part of their Building Safety Ordinance "Arizona Revised Statutes Title 41, Chapter 9, Article 8, Section 41-1492.03" the Arizonans with Disabilities Act, and

WHEREAS, federal statutes require that states adopt Titles II and III of the Americans With Disabilities Act of 1990, 42 U.S.C. §§ 12101 through 12213 and 47 U.S.C. §§ 225 and 611, and the implementing regulation adopted pursuant thereto, and

WHEREAS, the Navajo County Board of Supervisors did conduct noticed Public Hearings of proposed amendments to the Navajo County Building Safety Ordinance on September 2, 1997.

NOW, THEREFORE BE IT RESOLVED, the Navajo County Board of Supervisors adopts the following:

1. Amendment of Navajo County Building Safety Ordinance

The Building Safety Ordinance is hereby amended by adding the following language to the first paragraph of Section 1, the last line:

- “, and Title 41, Chapter 9, Article 8, Section 41-1492.03. “

2. Amendment of Navajo County Building Safety Ordinance

The Building Safety Ordinance is further amended, with the paragraphs (J) and (K) renumbered and by adding a new paragraph (J), with the following language, to the listing of codes:

- “(J) DISABILITY ACTS - All standards and specifications set forth or referred to in the Arizonans With Disabilities Act of 1992, A.R.S. §§ 41-1492 to 41-1492.12, as the same may be amended from time to time, and all implementing regulations adopted pursuant thereto (including without limitation Titles II and III of the Americans With Disabilities Act of 1990, 42 U.S.C. §§ 121101 through 12213 and 47 U.S.C. §§ 225 and 611, and the implementing regulations adopted pursuant thereto).”


NOW, THEREFORE BE IT ALSO RESOLVED, the Navajo County Board of Supervisors adopts the following:
