RESOLUTION NO. 114-97

**AUTHORIZATION TO SUBMIT APPLICATION and
ENTER INTO AN AGREEMENT FOR HOME FUNDS**

A resolution of the Board of Supervisors of Navajo County authorizing the submission of an application for FY 1997 HOME funds, certifying that said application meets the community's housing and community development needs and the requirements of the State HOME Program, and authorizing all actions necessary to implement and complete the activities outlined in said application.

WHEREAS, the Board of Supervisors of Navajo County is desirous of undertaking affordable housing development activities; and

WHEREAS, the State of Arizona is administering the HOME Program; and

WHEREAS, the State HOME Program requires that HOME funds benefit low income households; and

WHEREAS, the activity in the application addresses the community's low-income population housing needs; and

WHEREAS, a recipient of State HOME funds is required to comply with the program guidelines and Federal Statutes and regulations.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF SUPERVISORS OF NAVAJO COUNTY, authorize application to be made to the State of Arizona, Department of Commerce for FY 1997 State HOME funds, and authorize Eddie Koury, County Manager, to sign application and contract or grant documents for receipt and use of these funds, and authorize Clinton O. Shreeve, Finance Director, to take all actions necessary to implement and complete the activities submitted in said application; and




