WHEREAS, the roads within the said subdivision have been constructed to pavement standards in accordance with the Navajo County Subdivision Regulations and Requirements, as revised October 2, 1995; and

WHEREAS, the 1.53 miles of roadway have been inspected by County personnel during and after construction and have been found to conform to the above cited regulations; and


WHEREAS, the developer has petitioned Navajo County to accept the paved roads for road maintenance.


