#### RESOLUTION NO. 46-97

#### A RESOLUTION OF THE NAVAJO COUNTY BOARD OF SUPERVISORS ADOPTING AN AMENDMENT TO THE NAVAJO COUNTY GENERAL PLAN

The Navajo County Board of Supervisors does resolve as follows:

**WHEREAS**, the Navajo County Board of Supervisors and the Planning and Zoning Commission recognize the necessity for a Heber/Overgaard Area Specific General Plan as a guide in land use, economic development and public facility and services decision process; and

**WHEREAS**, the Heber/Overgaard Area Specific General Plan was formulated from public input as gathered from four (4) public scoping sessions held within the Heber/Overgaard area and at the duly noticed public hearings of the Planning and Zoning Commission and Board of Supervisors and is a policy of the citizens of Navajo County; and

**WHEREAS**, the Heber/Overgaard Area Specific General Plan is a policy plan by the people and for the people of the Heber/Overgaard area and, while not being detailed and specific in nature, it provides general recommendations which may be used by the Boards and Commissions of Navajo County in their statutory decision making processes, however, amendment of the Plan does not commit to an expenditure of County funds for implementation of its recommendations; and


**WHEREAS**, the Board of Supervisors does hereby declare and determine the following recommended amendment to the County General Plan was duly given and published, that a public hearing was duly held on the 21st day of April, 1997, and that the public necessity, convenience and general welfare require that the following amendment and change to the General Plan be made;


